INTRODUCTION

With effect from 1st June 2024, an employer (whose place of work is not included in any class or description of place of work as printed in the Gazette) is required, under OSHA section 29a(1), to appoint one of his employees to act as a Safety Coordinator if the company employ five or more employees at the place of work. Another key requirement is for the organisation to do a risk assessment on safety at the workplace.
